<u>City Council Meeting</u>: May 18, 2020. The use of the meeting room beside City Hall was a solution to keeping up with social distancing guidelines. All Council members and 14 citizens were present. Lorrie O'Hare representing the Scare & Share Productions brought before the council the insurance renewal application. Because of Covid-19, the Haunted House will not happen this year.

Resolution 2020-07 was approved to proceed with the annual municipal audit, scheduled for July 20, 2020.

The Personnel & Finance Committee recommended to hire Steve Martinenko for the Water Treatment Plant Operator under the license jurisdiction of Chuck Scholz, Harrisburg Public Works Director.

Chuck Scholz gave council a recap of problems and violations that need to be corrected at the Water Treatment Plant.

### **IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER**

### Contaminate, Total Trihalomethanes (TTHM) MCL Violation at The City of Monroe

Our water system recently violated a drinking water standard. Although this incident was not an emergency, as our customers, you have a right to know what happened and what we are doing to correct this situation.

We routinely monitor for the presence of drinking water contaminants. While testing results from January 1, 2020 through March 31, 2020 show our system did not exceed the standard, or maximum contaminant level (MCL), for TTHM, the total level averaged over the previous twelve months has exceeded the standard. The standard for TTHM is .080. It is determined by averaging all the samples collected at each sampling location for the past 12 months. The level of TTHM averaged at one of our system's locations for April 2019 through March 2020 was .089.

### What should I do?

- There is nothing you need to do. You do not need to boil your water or take other corrective actions. If a situation arises where the water is no longer safe to drink, you will be notified within 24 hours.
- If you have a severely compromised immune system, have an infant, are pregnant, or are elderly, you may be at increased risk and should seek advice from your health care providers about drinking this water.

#### What does this mean?

This is not an emergency. If it had been an emergency, you would have been notified within 24 hours.

TTHM are four volatile organic chemicals compounds which form when disinfectants react with natural organic matter in the water.

People who drink water containing trihalomethanes in excess of the MCL over many years may experience problems with their liver, kidneys, or central nervous system, and may have an increased risk of getting cancer.

### What is being done?

The City is adjusting its operations to move more water throughout its distribution system. This includes both monitoring the storage tank levels and instituting a quarterly fire hydrant flushing program to ensure water is moved around the City on a more frequent basis. We anticipate resolving the current issue within 180 days.

# FLUSHING WATER LINES ON

# JUNE 8TH - 12TH

Why does the City flush the water line? The city's water (which has naturally occurring high sedimentation) has some areas in town where water sits in the pipes for long periods of time, like dead ends of pipe. These are areas where sediment tends to gather. By flushing all the water lines twice a year (dead end lines get flushed 4 times a year), we are following and exceeding the states guidelines for a healthy water system. We are also able to check water flows and water pressure as we flush lines through town. This is to pro-actively identify other potential problems in the water distribution system. Flushing involves going to fire hydrants, blow-off and other designated flushing points in all neighborhoods, and running the water out at a high velocity, You will usually see large amounts of water moving down the street when this activity takes place in your neighborhood.

The City flushes all the City water lines in the Spring and again in the Fall. When the Public Work Crew is flushing nearby or in your neighborhood, you'll find your water pressure will be reduced for a short period of time. Because flushing the water line has a tendency to stir up sedimentation, it's a best practice to flush out your hot water heater, other water using appliances and your faucets soon after the flushing process has been completed. It's also a good idea to refrain from using large amounts of water, washing whites or light colored clothing on all flushing days.
